KINGS COUNTY ASSOCIATION OF GOVERNMENTS PUBLIC MEETING PROTOCOL IN RESPONSE TO CORONAVIRUS COVID-19

In light of the COVID-19 pandemic, California Governor Gavin Newsom issued Executive Order N-15-21, to delay the effective date of AB361 to October 1, 2021. On September 16, 2021, Governor Gavin Newsom signed into law AB 361 relating to the convening of public meetings, which will remain in effect until January 1, 2024. The Kings County Association of Governments (KCAG) hereby provides notice that it will continue to convene its regularly scheduled public meetings of the KCAG Commission via teleconference and as prescribed in AB 361 for public agencies until such date.

Members of the public who wish to participate in the meeting can do so one of two ways: via telephone, using the Call in Number and Participant Code noted on the meeting agenda and speaking during prescribed public comment time; or by postal or electronic mail. The public may submit written comments on any matter within the KCAG Commission's subject matter jurisdiction, regardless of whether it is on the agenda for KCAG Commission consideration or action, and those comments will be entered into the administrative record of the meeting. To submit written comments by U.S. Mail or email for inclusion in the meeting record, they must be received by the KCAG Office no later than 4:00 p.m. on the afternoon of the noticed meeting. To submit written comments by email, please forward them to Terri.King@co.kings.ca.us. To submit such comments by U.S. Mail, please forward them to KCAG, 339 W. D Street, Suite B, Lemoore, CA 93245.
